### **1. Content of the Workshop/Seminar:**

The Student Law Conclave emphasized on enhancing awareness of law as a career. The keynote speakers Honorable Retired High Court Judge S N Dhingra delivered a lecture on “Ethics in Legal profession” that gave information about ethical standards which legal professionals ought to follow and also spoke on the topic Rule of Law. After a short break Chief Judicial Magistrate (CJM) Sunil Chauhan talked about the importance of legal literacy and the Right to Free Legal Aid U/A 39(A). This was followed by Mr. Gaurav Bhatara, Founder and Director of AB Tutorials, he discussed on the scope of law in India and the reason for its mushrooming growth.

### **2. Learning outcomes (Knowledge and Information) from the workshop/Seminar?**

The law conclave was more than an informative one. There was a Plethora of Sagacious words and lessons which were imbibed by students. Some of these would be-

- Aims and Objectives of Legal Services Authorities Act, 1987.
- Complex Trial Procedures
- Rights available to arrested persons according to the Landmark Judgement given by Supreme Court in D K Basu’s case.

### **3. Which topics or aspects of the workshop/Seminar did you find most interesting or useful and can be applied to the classroom teaching?**

One of the aspects that took a lot of interest of students was the discussion of non-adjudicatory method preferred by parties to solve their disputes i.e. ADRS (Alternative Dispute Resolution System) which involves techniques like Arbitration, Conciliation, Mediation and Lok Adalats for

speedy Settlement of the disputed matter.

**4. How will you implement the knowledge & techniques acquired to your subject?**

With the help of knowledge gained through this conclave, various important topics such as Rule of Law, Article 14 and 15, Trial procedures and its stages, Article 39(A)- Free legal aid can be discussed with the students in the class via question-answer method, extempore or by giving Hypothetical situations to make them understand and interpret accordingly.
