- You are requested to forward your choice between **HINDI / SANSKRIT / FRENCH**, taught as Second Language in Class IX for the academic session 2018-19. Kindly indicate the choice of subject in respect of your ward only on the form given below.
- Financial skills particularly in the 21<sup>st</sup> century are as important as Computer skills. It not only empowers a person to take informed judgements and decisions regarding the use and management of money but also helps to crack competitive examinations like CA, ICWA etc.
- Keeping this perspective in mind, CBSE in collaboration with National Stock Exchange (NSE) has introduced Financial Market Management (FMM) as a vocational course at Level I and Level II for Classes IX & X from the academic session 2015-16. As per the scheme of studies, students have the choice of studying the subject of '**Basics of Money Management**' in Class IX and '**Introduction to Financial Markets**' in Class X as 6<sup>th</sup> subject. The school has been running the course successfully in Classes IX and X for two years now. An examination fee of Rs.1000/- each for Class IX as well as X is to be paid for the course. At the end of the course, a joint certification will be awarded by CBSE and NSE. Interested students are required to indicate the choice for opting this course in the form attached along with the circular. It may be noted that those students who intend to study Commerce at +2 level, the proposed 6<sup>th</sup> optional subject will prove to be beneficial in the long run.
- The remaining 05 subjects will be as per scheme of studies for Classes IX & X.
- The completed form is to be submitted to the Class Teacher positively on 20 Jan, 2018 (Saturday) during the Interactive PTM. Plain paper applications will not be entertained.
