- CBSE in collaboration with National Stock Exchange (NSE) has introduced Financial Market Management (FMM) as a vocational course at Level I and Level II for Classes IX & X from the academic session 2015-16. As per the scheme of studies, students have the choice of studying the subject of '**Basics of Money Management**' in Class IX and '**Introduction to Financial Markets**' in Class X as 6<sup>th</sup> subject. The school has been running the course successfully in Classes IX and X for five years now. **An examination fee of Rs.1000/- each** for Class IX as well as X is to be paid for the course which is to be paid by Cheque. The fee for opting AI is Rs.500/- per month. **Artificial Intelligence & Machine Learning, Coding, Python are the subjects of near future and are in great demand.**
