



## **OPERATION OF SWIMMING POOL**

Dear Parents,

Swimming is an essential life skill and a great recreational sport that can be enjoyed by people of all ages. Our children have missed out the use of swimming pool since the last two years due to the Covid 19 pandemic. The Swimming Pool operations will start this month, in accordance with the guidelines issued by Ministry of Health, to prevent the spread of COVID-19. Also, attached is the permission from U.P. Govt. to operate Swimming Pools.

Swimmers using the swimming pool will :

- Comply with all the instructions displayed around the pool.
- Observe the rules of personal hygiene displayed all over the swimming pool area

**No student displaying suggestive Covid 19 symptoms (fever, cold, cough, sneezing, sore throat, diarrhoea, vomiting etc) will be allowed inside the pool.**

### **Swimming Pool Protocol**

- Students will NOT enter the pool until 5 min. before their scheduled practice.
- They will not rush to the pool together, they must enter the pool one at a time A lady guard will constantly monitor the student movement.
- There will be a scheduled 10 min. window between periods for students to exit the pool before the start of the next period. This will give the Support staff time to clean the deck prior to the next practice.
- Students must carry personal face mask, swimwear, towel, cap, goggles, water bottle and mesh bag. No other items should be brought to the facility.

Once the swimmers are inside the pool, they will -

- Take an obligatory shower before using the swimming pool.
- Take a shower every time they use the toilet.
- Use the obligatory foot basin containing a 0.3-0.6% chlorine solution to disinfect their feet before entering the swimming pool.
- Wear waterproof head gear (swim cap).
- Not enter the swimming pool if they suffer from a dermatological disease. People with extended abrasions, blisters or open wounds should get information about the risk of infection and avoid entering the swimming pool.

### **Protocols During Practice**

- All practices will occur with 1 swimmer per lane (lanes are all at least 7ft wide). Maximum number of swimmers at a time will be 1 swimmer per 5 sqm of water surface
- All locker rooms and bathrooms will be constantly cleaned and sanitized between practices.
- All coaches, students and lifeguard staff will bring their own water bottle to the pool.
- The students may NOT share any equipment they should have their own equipment.
- Students will not be allowed to congregate in groups of any size before, during, and after practice.
- Coaches will NOT huddle with the students before, during or after practices.
- Coaches & other staff will be in masks during their time at the pool.
- All people to remain at least 6 ft. away from each other
- Swim bags and equipment bags will be limited and taken home after every practice. Students will not store equipment bags at the pool.

All Medical Alert Notification cases are required to submit papers to the Class Teachers duly signed by the Doctor for school records.

School will maintain the highest standards of safety and hygiene and will not be responsible for any injury or accident.

The Swimming Pool will remain operational during the Summer Break and parents wanting to send their wards for regular swim may do so. Kindly carry ID card to swim during vacation time.

महोदय,


कोरोना संक्रमण की रोकथाम हेतु ग्रेडेड रिस्पॉन्स के संबंध में गृह (गोपन) अनुभाग-3 के आदेश संख्या-1054/2021-सीएक्स-3, दिनांक 19.06.2021, आदेश संख्या-15/2022-सीएक्स-3, दिनांक 04.01.2022, आदेश संख्या-34/2022-सीएक्स-3, दिनांक 05.01.2022 तथा आदेश संख्या-237/2022-सीएक्स-3, दिनांक 11.02.2022 का कृपया संदर्भ ग्रहण करें।

2. उल्लेखनीय है कि वर्तमान में विभिन्न आदेशों के माध्यम से अधिकांश गतिविधियाँ पूर्णरूप से प्रारम्भ कर दी गयी हैं परन्तु स्वीमिंग पूल/वाटर पार्क, आंगनबाड़ी केन्द्रों को खोलने एवं शादी समारोह/अन्य आयोजनों में कतिपय प्रतिबन्ध प्रभावी हैं।

3. इस संबंध में मुझे यह कहने का निदेश हुआ है कि वर्तमान में प्रदेश में कोरोना संक्रमण की दरों में प्रभावी रूप से कमी होने के दृष्टिगत सम्यक् विचारोपरांत निम्नलिखित निर्णय लिया गया है:-

- (1) समस्त स्वीमिंग पूल/वाटर पार्क खुले रहेंगे।
- (2) आंगनबाड़ी केन्द्र खुले रहेंगे।
- (3) शादी समारोह व अन्य आयोजनों में बन्द स्थानों एवं खुले स्थानों में मास्क की अनिवार्यता एवं कोविड-19 प्रोटोकाल के अनुसार अन्य सावधानियों बरतते हुए पूर्ण क्षमता के साथ व्यक्तियों के सम्मिलित होने की अनुमति होगी।
