- b. **Memorials:** Teams were required to submit written memorials presenting their arguments and legal analysis on behalf of the appellant or respondent. These memorials were assessed by the judges prior to the oral proceedings.
- c. **Oral Arguments:** The participants presented their arguments before the panel of judges, following a predetermined sequence. Each team was given a specific time limit to present their case, cross-examine witnesses, and respond to the opposing team's arguments.



FINAL ARGUMENTS BEING PRESENTED

The judges evaluated participants based on various criteria, including legal reasoning, clarity of arguments, presentation skills, research, and knowledge of relevant laws. The participants' ability to respond to queries from the bench and counter-arguments from the opposing team was also taken into account.
