Dear Parent,

You are requested to forward your choice between HINDI / SANSKRIT taught as Second Language in Class IX for the academic session 2024-25. Kindly indicate the choice of Second language in respect of your ward only on the form given below.

CBSE in collaboration with National Stock Exchange (NSE) has introduced Financial Market Management (FMM) as a vocational course at Level I and Level II for Classes IX & X from the academic session 2015-16. As per the scheme of studies, students have the choice of studying the subject of 'Basics of Money Management' in Class IX and 'Introduction to Financial Markets' in Class X as 6th subject. The school has been running the course successfully in Classes IX and X for seven years now. An examination fee of Rs.1000/- each for Class IX as well as X is to be paid for the course which is to be paid by Cheque. At the end of the course, a joint certification will be awarded by CBSE and NSE. Interested students are required to indicate the choice for opting this course in the form attached along with the circular. It may be noted that those students who intend to study Commerce at +2 level, the proposed 6th optional subject will prove to be beneficial in the long run.

Under the aegis of CBSE, the school introduced Artificial Intelligence as 6th subject for the students of Class IX in Session 2018-19. The objective of this subject is to develop a readiness for understanding and appreciating Artificial Intelligence and its application in our lives. The fee for opting AI is Rs.550/- per month. Artificial Intelligence & Machine Learning, Coding, Python are the subjects of near future and are in great demand.
